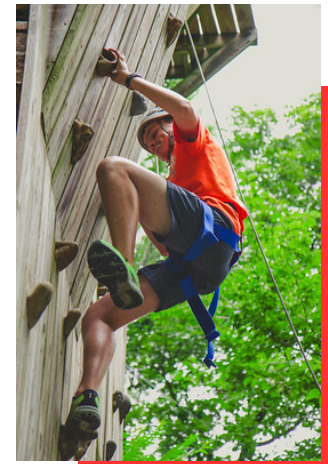
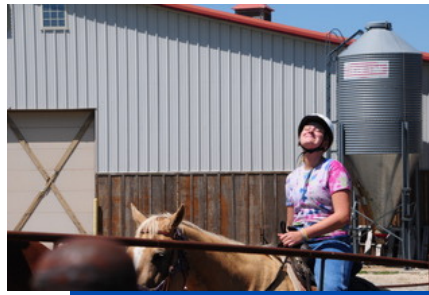

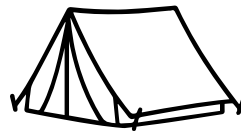

OUR IMPACT

Perhaps the most powerful and lasting benefit of these summer camps is the sense of community they inspire. There's something truly priceless about discovering a place where you belong—surrounded by others who just get you, because they've walked a similar path.

"Thank you so much for a wonderful experience. [My son] had so much fun, but he told me his biggest takeaway was being around other kids who had all gone through the same experience. That is so powerful as it can feel so isolating at times." -- Parent of camper at Camp ChiMer, serving children with end-stage renal disease.

"About a year ago Nelly, at age 8, started realizing that she was kept alive by a machine. She also started becoming aware that none of the other kids in her elementary school had heart problems like her. She felt alone. She's never in her whole life had an experience like she did this week [at camp]. A whole group of kids . . . LIKE HER. She hasn't stopped talking about camp since we got home. "Some kids who are post-transplant still feel self-conscious about their scars. Ethan, one of our campers, whipped off his shirt, spun it above his head, and shouted that he didn't care—everyone here was just like him. Then he leapt into the pool! He had the most amazing time simply being a kid and feeling comfortable in his own skin.
